4.1. NIPA PCL 56 - Recess Self Storage - 8405 Washington Blvd. - PL17-0105

REQUEST

The applicant requests approval of a Design Review Permit to allow a 115,065-square-foot self-storage facility, consisting of one three-story building (a portion of which would be climate controlled) and two two-story buildings; and associated parking, lighting, and landscaping. The request also includes a Tentative Parcel Map to merge and re-subdivide 13 existing parcels into three (3) parcels.

SUMMARY RECOMMENDATION

The Planning Division recommends that the Design Committee take the

following actions:

- A. Adopt the Recess Self Storage and Washington Crossing Flex Industrial Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program;
- B. Adopt the four (4) findings of fact and approve the Design Review Permit subject to seventy-eight (78) conditions of approval; and,
- C. Adopt the three (3) findings of fact and approve the Tentative Parcel Map subject to sixty-one (61) conditions of approval.

Associate Planner, Shelby Vockel, presented the staff report.

Chair Mendonsa invited questions from the committee members.

- Location of the air conditioner unit.
- Proposed landscaping is beautiful.
- Like the colors and design of the buildings.
- Will the existing landscape be preserved?
- The architecture matches the recently designed hotels on Washington Blvd.

Applicant representative, Reid Hamilton, American Recess, stated he had received a copy of the staff report and was in agreement with staff's recommendations. He thanked City staff for their responsiveness. He also responded to committee members' questions regarding the location of the air conditioning unit.
