Purpose. Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

The new developments Main Street Plaza Apartments and Roseville Apartments will allow for 30 RHA families to utilize project-based vouchers to lease up in brand new units in 2020 and 2021. RHA will continue to look for developments to apply project-based vouchers to increase affordable housing opportunities for income eligible families.</p>

B.3 Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.

Goals for the current 5-Year Plan:

1. Expand the supply of assisted housing.
 - *The Roseville Housing Authority (RHA) will apply for additional VASH vouchers if they become available.*
 - *PROGRESS: RHA had the opportunity to apply for more VASH vouchers and was awarded 5 in January 2020.*
 - *PROGRESS: RHA, with the support of the VA, was awarded 25 more VASH vouchers in January 2021.*
 - *The Roseville Housing Authority will apply for additional Mainstream vouchers if they become available.*
 - *PROGRESS: RHA with support of local support service providers was awarded 11 more Mainstream vouchers in January 2020 and an additional 8 in August 2020.*
2. Improve the quality of assisted housing.
 - *The Roseville Housing Authority will maintain its high-performer rating (SEMAP score).*
 - *PROGRESS: RHA received the high-performer rating again this year.*
 - *PROGRESS: RHA has initiated project-based vouchers as an option so that the quality of housing assisted by the program is further reviewed by RHA. In a community with a low vacancy rate, it is important to provide vouchers a priority to new and high quality housing opportunities.*
 - *PROGRESS: RHA has continued lease up of the new developments Main Street Plaza Apartments and Roseville Apartments which when complete will allow for a total of 30 families to be housed in brand new units.*
3. Increase assisted housing choices.
 - *The Roseville Housing Authority will continue to encourage property owners to provide available unit information for Housing Choice Voucher holders that are searching for a rental unit.*
 - *PROGRESS: RHA maintains a list of available rental units that it encourages owners to utilize for available units.*
 - *PROGRESS: 2021 RHA implemented landlord property listing online through GOsection8.com enabling landlords to list available properties through an online portal.*
 - *The Roseville Housing Authority will monitor HAP payments monthly to ensure that at least 98% of the Annual Contributions Contract is utilized or that 98% of total unit months are leased each year.*
 - *PROGRESS: For calendar year 2020 RHA utilized 91.9% of regular HCV vouchers, 100% of NED vouchers and 80.2% of VASH vouchers and the RHA is working within the budget, and in partnership with housing owners and managers and the Department of Veteran's Affairs to fully utilize all regular, NED, and VASH vouchers. While vouchers were not fully leased, over 100 percent of the Annual Contributions Contract was utilized, including use of program reserve funding.*
4. Affirmatively further Fair Housing
 - *The Roseville Housing Authority will provide training opportunities for staff to promote equal opportunity in housing.*
 - *PROGRESS: During 2020 RHA staff attended various online training seminars.*
 - *PROGRESS: The Roseville Housing Division reserved \$50,000 to retain a Fair Housing firm to provide legal services for residents.*
 - *PROGRESS: RHA staff is scheduled for Fair Housing Training in January 2021.*
5. Collaborate with neighboring housing authorities to optimize administration of the Housing Choice Voucher Program.
 - *The Roseville Housing Authority maintains a close relationship surrounding housing authorities.*
 - *PROGRESS: RHA maintains a list of Northern California Housing Authority contacts to ask for opinions about new policies and maintain ongoing communication. RHA also maintains a collaborative relationship with Placer County Housing Authority.*

RHA Mission Statement:

The mission of the Roseville Housing Authority is to enhance the quality of life to Roseville and Rocklin's low-income families and individuals by:

- Effectively administering Housing Choice Voucher rental assistance funds
 - *PROGRESS: The Roseville Housing Authority has effectively administered Housing Choice Voucher rental assistance funds by monthly reviewing available funds and lease-up to determine further leasing strategy. This has resulted in utilizing the full budget authority for the last calendar year and a small portion of reserve funds.*
- Assisting families with opportunities for safe, decent and affordable housing
 - *PROGRESS: By carefully monitoring lease-up, success rate, and market trends we ensure that we are able to assist the largest number of families. Our 2020 utilization of unit count is 96%.*
- Delivering a high level of customer service
 - *PROGRESS: We consistently provide a high level of customer service. This is evidenced, in part, by our practice of giving out our direct lines to owners and participants, and when unable to answer the call personally, return the call no later than the next business day. When we receive RFTAs we strive to approve them as soon as possible and complete the move-in inspection within 2 business days of when the unit is available for inspection.*

- *PROGRESS: With the implementation of GOsection8.com, participants will be able to search online for available units. Property managers and landlords will be able to list their available properties/units through the online portal free of charge giving applicants and participants easier access to unit information.*
- Guiding families and individuals towards self-sufficiency
 - *PROGRESS: During the last year, two households successfully completed the FSS program. Both families received escrow money and both are considering withdrawing from the rental assistance program and moving into non-subsidized housing yet both families are being mindful of how COVID-19 is going to potentially impact any decision they make.*

C.4 Certification by State or Local Officials. Form HUD-50077-SL, *Certification by State or Local Officials of PHA Plans Consistency with the Consolidated Plan*, must be submitted by the PHA as an electronic attachment to the PHA Plan. (24 CFR §903.15)

D. Statement of Capital Improvements.

PHAs that receive funding from the Capital Fund Program (CFP) must complete this section. (24 CFR 903.7 (g))

D.1 Capital Improvements. In order to comply with this requirement, the PHA must reference the most recent HUD approved Capital Fund 5 Year Action Plan. PHAs can reference the form by including the following language in Section C. 8.0 of the PHA Plan Template: "See HUD Form 50075.2 approved by HUD on XX/XX/XXXX."
