Purpose. Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

RHA continues to look for developments to apply project-based vouchers to increase affordable housing opportunities for income eligible families. In October 2021 RHA accepted RFPs from property owners and developers for New Construction and Newly Rehabilitated housing units requesting PBVs. Approximately 75 PBVs were made available under the RFP. RHA’s goal is to support a number of projects throughout the city in areas with low poverty concentration.

In addition to the items listed in **B.3.** for furthering the progress of PHA 5 – Year Plan, project-basing vouchers also works to address the issue of having the availability and adequacy of affordable housing for extremely low income households. The PHA Plan speaks to expanding the supply of assisted housing for this income group as a local housing need. Project basing units for this income category allows RHA to review the quality of the housing and ensure the provision of such housing units.

B.3 Progress Report.

Goals for the current 5-Year Plan:

1. Expand the supply of assisted housing.
 - (a) **PROGRESS:** HUD awarded 50 Emergency Housing Vouchers to RHA in June 2021 to administer.
 - (b) **PROGRESS:** RHA made 75 PBVs available under an RFP in October 2021
 - o The Roseville Housing Authority will apply for additional VASH vouchers if they become available.
 - (c) **PROGRESS:** RHA had the opportunity to apply for additional HUD VASH vouchers and with the support of the VA was awarded 25 vouchers in January 2021
PROGRESS: RHA applied in was awarded 10 HUD VASH vouchers in January 2022.
2. Improve the quality of assisted housing.
 - o The Roseville Housing Authority will maintain its high-performer rating (SEMAP score).
 - (b) **PROGRESS:** Due to the COVID – 19 Pandemic and HUD administered waivers, RHA maintained its current high-performer rating.
 - (c) **PROGRESS:** RHA administering project-based vouchers as an option so that the quality of housing assisted by the program is further reviewed by RHA. In a community with a low vacancy rate, it is important to provide vouchers a priority to new and high quality housing opportunities.
3. Increase assisted housing choices.
 - o The Roseville Housing Authority will continue to encourage property owners to provide available unit information for Housing Choice Voucher holders that are searching for a rental unit
 - (a) **PROGRESS:** 2021 RHA implemented landlord property listing online through AffordableHousing.com (formerly GOsection8.com) enabling landlords to list available properties through an online portal.
 - o The Roseville Housing Authority will monitor HAP payments monthly to ensure that at least 98% of the Annual Contributions Contract is utilized or that 98% of total unit months are leased each year.
 - (b) **PROGRESS:** For CY 2021 RHA utilized 91.9 of regular HCV vouchers, 98.0% of NED vouchers, 88.1% of Mainstream vouchers, and 61.8% of HUD VASH vouchers. RHA is working within the budget and in partnership with housing owners and managers and the Department of Veteran’s Affairs to fully utilize all regular, NED, and HUD VASH vouchers. While vouchers were not fully leased, over 100 percent of the Annual Contributions Contract was utilized, including the use of program reserve funding.
4. Affirmatively further Fair Housing
 - o The Roseville Housing Authority will provide training opportunities for staff to promote equal opportunity in housing.
 - (a) **PROGRESS:** RHA staff attended Fair Housing Training provided by HUD in January 2021.
 - (b) **PROGRESS:** The Roseville Housing division reserved \$50,000 to retain a Fair Housing Agency to provide legal services for residents.
 - (c) **PROGRESS:** During 2021 RHA staff attended various online training seminars and more are scheduled for 2022.
5. Collaborate with neighboring housing authorities to optimize administration of the Housing Choice Voucher Program.
 - o The Roseville Housing Authority maintains a close relationship with surrounding housing authorities.
 - (a) **PROGRESS:** RHA maintains a list of Northern California Housing Authority contacts to ask for opinions about new policies and best practices. RHA maintains a close collaborative relationship with Placer County Housing Authority, often working in cooperation on various projects such as the FSS and EHV programs.

RHA Mission Statement:

The mission of the Roseville Housing Authority is to enhance the quality of life to Roseville and Rocklin’s low-income families and individuals by:

- o Effectively administering Housing Choice Voucher rental assistance funds.
 - (a) **PROGRESS:** The Roseville Housing Authority has effectively administered Housing Choice Voucher rental assistance funds by monthly reviewing available funds and lease-up to determine further leasing strategy. This has resulted in utilizing the full budget authority for the last calendar year and a small portion of reserve funds.
- o Assisting families with opportunities for safe, decent and affordable housing.
 - (a) **PROGRESS:** By carefully monitoring lease-up, success rate, and market trends we ensure that we are able to assist the largest number of families. Our 2021 utilization of unit count is 95%.
- o Delivering a high level of customer service
 - (a) **PROGRESS:** We consistently provide a high level of customer service. This is evidenced, in part, by our practice of giving out our direct lines to owners and participants, and when unable to answer the call personally, return the call no later than the next business day. When we receive RFTAs we strive to approve them as soon as possible and complete the move-in inspection within 2 business days of when the unit is available for inspection.

	<p>(b) PROGRESS: With the implementation of <i>AffordableHousing.com</i>, participants are able to conveniently search online for available units. Property managers and landlords are able to list their available properties/units through the online portal free of charge giving applicants and participants easier access to unit information.</p> <p>(c) PROGRESS: RHA staff participated in two customer service trainings in 2022 and will continue to seek out and attend training that allows for staff to improve upon their customer service skills.</p> <ul style="list-style-type: none"> o Guiding families and individuals towards self-sufficiency <ul style="list-style-type: none"> (a) PROGRESS: In 2021 Placer County Housing Authority became a joint applicant with RHA on the FSS NOFA. This collaboration will result in the two PHAs working together to share resources, a PCC, and ideas. (b) PROGRESS In 2021 RHA's FSS Program had a household graduate with escrow. The family has successfully become self-sufficient and free of housing assistance. The FSS program has a new coordinator who is attracting participants to participate in the program and the number of participants in on a steady increase.

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations, impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction’s initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).
