Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

The \$65,000 grant assisted with the establishment of an owner incentive program.</p> <p>The Homeless Resource Council of the Sierras awarded RHA a \$100,000 grant through the Homeless Housing, Assistance and Prevention Program Round Three (HHAP3) grant. This grant is for the continued operation of RHA's owner incentive program and landlord liaison activities.</p>

B.3 Progress Report.

Provide a description of the PHA's progress in meeting its Mission and Goals described in its 5-Year PHA Plan.

RHA Mission Statement:

The mission of the Roseville Housing Authority is to provide opportunity for decent, safe and sanitary affordable housing to very low and extremely low-income families in Roseville and Rocklin by:

- **Effectively administering Housing Choice Voucher rental assistance funds**
 - (a) **PROGRESS:** *The Roseville Housing Authority has effectively administered Housing Choice Voucher rental assistance funds by monthly reviewing available funds and lease up to determine further leasing strategy. This has resulted in utilizing the full budget authority for the last calendar year, short fall funding as well as reserve funds keeping all families housed.*
 - (b) **PROGRESS:** *RHA maintained its "high performer" rating (SEMAP)*
- **Assisting families with opportunities for safe, decent and affordable housing.**
 - (a) **PROGRESS:** *By carefully monitoring market trends, lease-up, and success rates, RHA assisted the largest number of families possible. 2023 utilization for HCV vouchers was 96.7%*
 - (b) **PROGRESS:** *RHA established an owner incentive program with a total of \$165,000 in grant funds. This program has increased the number of new landlords who entered into a HAP contract with RHA, ultimately giving families more opportunities to find a unit.*
- **Delivering a high level of customer service**
 - (a) **PROGRESS:** *RHA assigned one staff member to be the Landlord Liaison so they have one point of contact to answer questions and receive information about the HCV program and RHA policies and procedures.*
 - (b) **PROGRESS:** *RHA reorganized the housing caseloads by landlord. The reorganization pairs large properties with one technician instead of property owners/managers having to speak to several housing technicians. This reorganization allows for more consistent and cohesive communication.*
 - (c) **PROGRESS:** *RHA's level of customer service remains high. Both owners and participants have direct phone numbers and emails for their caseworkers and all calls are returned no later than the next business day. RFTAs are approved as soon as possible and move-in inspection are completed within 2 business days of when the unit is available for inspection.*
 - (d) **PROGRESS:** *Partnering with AffordableHousing.com has enabled property managers and landlords to list their available properties/units through the online portal free of charge giving applicants and participants easier access to available unit information.*
- **Encouraging family self-sufficiency**
 - (a) **PROGRESS:** *Roseville Housing Authority continues its collaboration with Placer County Housing Authority (PCHA). This joint effort includes the complete revamp of the Program Coordinating Committee (PCC). PCHA's strong Placer County connections to resources and services and RHA's access to Roseville Rocklin area resources have resulted in a strong and active PCC.*
 - (b) **PROGRESS:** *RHA had 6 new participants enroll in the FSS Program in 2023 making a total of 26 active participants at the end of the year. 3 participants completed their COP and collected \$28,683 in escrow.*
 - (c) **PROGRESS:** *FSS staff intends on expanding the number of participants it currently serves. The current goal is to maintain 24 FSS participants, this is being expanded to 30 participants.*

The mission shall be accomplished by a fiscally responsible, creative organization committed to excellence in public service.

Goals for the current 5-Year Plan:

- 1. Expand the supply of assisted housing.**
 - (a) **PROGRESS:** *After making 75 PBVs available under an RFP, RHA received 6 applications from developers and awarded 60 PBV in total for all projects. An additional 8 PBVs were awarded to a Permanent Supportive Housing project.*
 - (b) **PROGRESS:** *HUD awarded RHA 8 additional HCVs on October 1, 2022. This was the first award of regular vouchers in over 12 years.*
 - (c) **PROGRESS:** *RHA applied for and was awarded 10 HUD VASH vouchers in February 2023.*
 - (d) **PROGRESS:** *RHA continues to look for opportunities to apply for more vouchers as NOFO's are released from HUD.*
- 2. Improve the quality of assisted housing.**
 - (a) **PROGRESS:** *RHA is administering project-based vouchers, mainly to new developments as an option so that the quality of housing assisted by the PBV program is further reviewed by RHA. In a community with a low vacancy rate, it is important to make PBV vouchers a priority to assist with production of new and high-quality housing opportunities.*
 - (b) **PROGRESS:** *RHA performs biennial Housing Quality Standards inspections for all program participants.*
- 3. Increase assisted housing choices.**

The Roseville Housing Authority will continue to encourage property owners to provide available unit information for Housing Choice Voucher holders that are searching for a rental unit.

- (a) **PROGRESS:** *In 2023, RHA established an owner incentive program which helped attracting 29 new owners to the program.*
- (b) **PROGRESS:** *RHA has a dedicated staff member that landlords can contact directly to get information about the HCV program and have their questions answered about RHA policies and procedures.*
- (c) **PROGRESS:** *RHA continues to encourage landlords to list their available units through the AffordableHousing.com portal. This service is free for landlords with a basic listing and free to participants searching for units.*

The Roseville Housing Authority will monitor HAP payments monthly to ensure that at least 98% of the Annual Contributions Contract is utilized or that 98% of total unit months are leased each year.

- (d) **PROGRESS:** *For CY 2023 RHA utilized 96.8% of regular HCV vouchers, 99.2% of NED vouchers, 77.9% of Mainstream vouchers, 78.8% of EHV and 70.2% of HUD VASH vouchers. RHA is working within the budget and in partnership with housing owners and managers and the Department of Veteran's Affairs to fully utilize all HCV, NED, Mainstream, EHV and HUD VASH vouchers. While vouchers were not fully leased, over 100 percent of the Annual Contributions Contract was utilized, including the use of program reserve funding as well as shortfall funds.*

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations, impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction’s initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).

C.4 Challenged Elements. If any element of the Annual PHA Plan or 5-Year PHA Plan is challenged, a PHA must include such information as an attachment to the Annual PHA Plan or 5-Year PHA Plan with a description of any challenges to Plan elements, the source of the challenge, and the PHA’s response to the public.

D. Affirmatively Furthering Fair Housing (AFFH).

D.1 Affirmatively Furthering Fair Housing. The PHA will use the answer blocks in item D.1 to provide a statement of its strategies and actions to implement each fair housing goal outlined in its accepted Assessment of Fair Housing (AFH) consistent with 24 CFR § 5.154(d)(5) that states, in relevant part: “To implement goals and priorities in an AFH, strategies and actions shall be included in program participants’ ... PHA Plans (including any plans incorporated therein) ... Strategies and actions must affirmatively further fair housing ...” Use the chart provided to specify each fair housing goal from the PHA’s AFH for which the PHA is the responsible program participant – whether the AFH was prepared solely by the PHA, jointly with one or more other PHAs, or in collaboration with a state or local jurisdiction – and specify the fair housing strategies and actions to be implemented by the PHA during the period covered by this PHA Plan. If there are more than three fair housing goals, add answer blocks as necessary.

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.

This information collection is authorized by Section 511 of the Quality Housing and Work Responsibility Act, which added a new section 5A to the U.S. Housing Act of 1937, as amended, which introduced the Annual PHA Plan. The Annual PHA Plan provides a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA’s operations, programs, and services, and informs HUD, families served by the PHA, and members of the public for serving the needs of low- income, very low- income, and extremely low- income families.

Public reporting burden for this information collection is estimated to average 6.02 hour per response, including the time for reviewing instructions, searching existing data sources, gathering and maintaining the data needed, and completing and reviewing the collection of information. HUD may not collect this information, and respondents are not required to complete this form, unless it displays a currently valid OMB Control Number.
