**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

<b>B.3</b>	<p><b>Progress Report.</b></p> <p>Provide a description of the PHA's progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p><b>The mission of the Roseville Housing Authority is to provide opportunity for decent, safe, and sanitary affordable housing to very low and extremely low-income families in Roseville and Rocklin.</b></p> <p><b>Roseville Housing Authority's 5-Year Plan Goals are:</b></p> <p><b>1. Expand the supply of assisted housing.</b></p> <p>a. <b>PROGRESS:</b> RHA has a total of 100 VASH vouchers. RHA received 10 VASH vouchers in 2023 and an additional 15 awarded in 2024. Roseville Housing Authority (RHA) will apply for additional VASH vouchers if they become available.</p> <p>b. <b>PROGRESS:</b> RHA has a total of 43 Mainstream (MS) vouchers which are fully leased at 100% with a waitlist. Roseville Housing Authority (RHA) will apply for additional Mainstream vouchers if they become available.</p> <p>c. <b>PROGRESS:</b> RHA was awarded 20 Foster Youth to Independence (FYI) vouchers in August 2024 and will continue to apply for additional FYI and Foster Care Unification (FUP) vouchers when made available.</p>					

	<p><b>2. Improve the quality of assisted housing.</b></p> <p>a. <b>PROGRESS:</b> Currently, 46 PBV units are under HAP contract, achieving a 100% lease rate. 16 additional new build and renovated PBV units are scheduled to be completed and leased by the end of 2025, including 4 VASH PBVs.</p> <p>b. <b>PROGRESS:</b> RHA has maintained SEMAP High Performer status rating for 20 years.</p> <p><b>3. Increase assisted housing choices.</b></p> <p>a. <b>PROGRESS:</b> RHA encourages and recommends that property owners list their available units on AffordableHousing.com. This service is free for owners who would like to list basic rental unit information.</p> <p>b. <b>PROGRESS:</b> In 2023 RHA established an owner's incentive program in hopes of attracting new owners to the HCV program. The program remains successful and, to date, the incentive program has attracted 64 new property owners.</p> <p>c. <b>PROGRESS:</b> Roseville Housing Authority (RHA) is making significant strides in providing more housing options for residents in Roseville and Rocklin. Successes of previous projects reaching full occupancy is a promising indicator of the demand and effectiveness of these projects. With new Project-Based Voucher (PBV) projects coming online, RHA is well-positioned to continue expanding housing choices.</p> <p><b>4. Affirmatively further Fair Housing.</b></p> <p>a. <b>PROGRESS:</b> RHA works closely with Project Sentinel, a fair housing agency, to provide fair housing and reasonable accommodation training at least once a year to housing authority staff, property management and owners, and the public. Housing Authority staff attended fair housing training in April 2024.</p> <p><b>5. Collaborate with neighboring housing authorities to optimize administration of the Housing Choice Voucher Program.</b></p> <p>a. <b>PROGRESS:</b> RHA continues to collaborate with PCHA on various PHA programs, including the EHV program and VASH vouchers. Our most recent partnership with Placer County Housing Authority (PCHA) involves the FSS program.</p> <p>b. <b>PROGRESS:</b> RHA continues its FSS program collaboration with PCHA through the joint FSS Program Coordinating Committee. The committee meets quarterly and consistently adds new members and resources.</p> <p>c. <b>PROGRESS:</b> RHA collaborates with PHAs throughout Northern California to share information, facilitating improvements in program administration, strategies for avoiding shortfall, and improve Port Out/Port In procedures.</p>

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further

fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction's initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
