

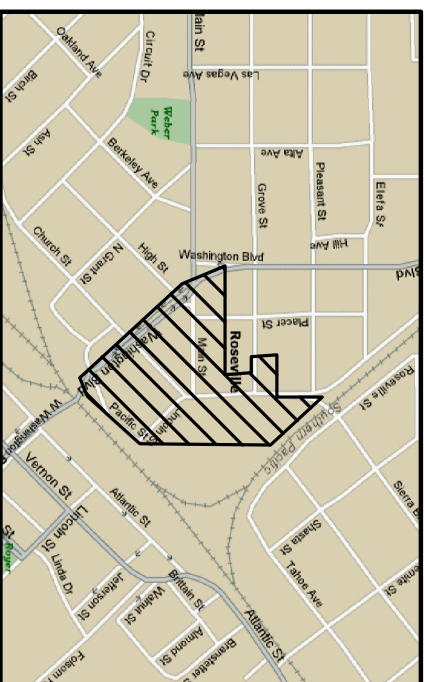
BOUNDARY MAP OF
