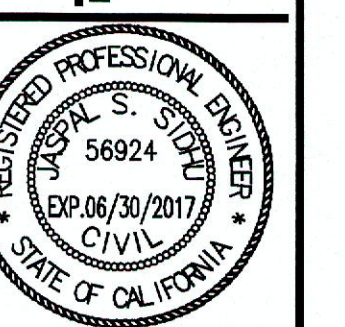


RIGHT ELEVATION (EAST)

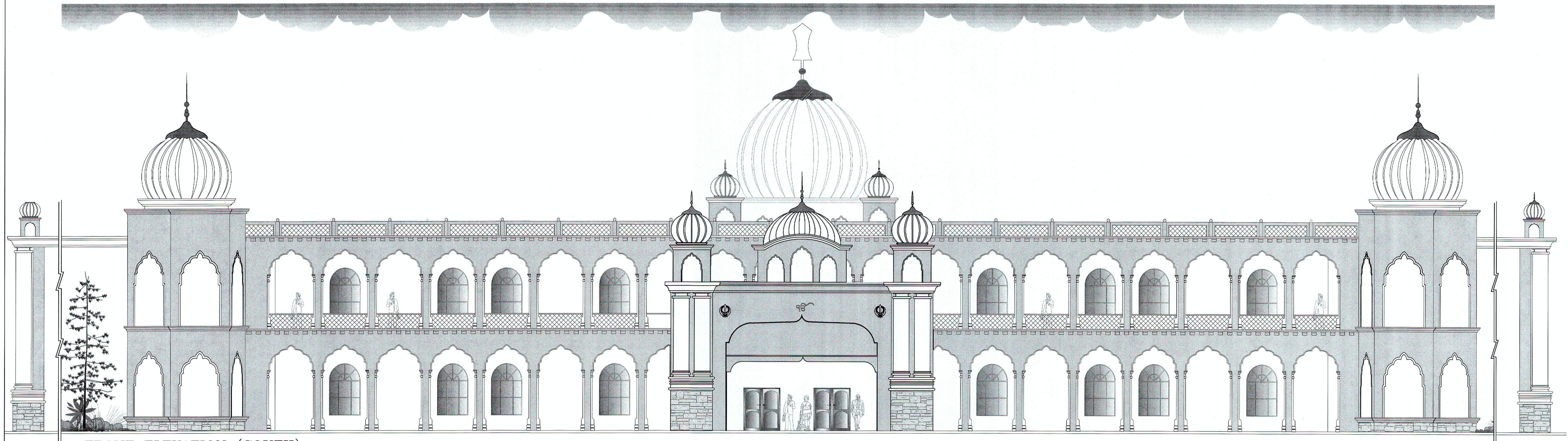

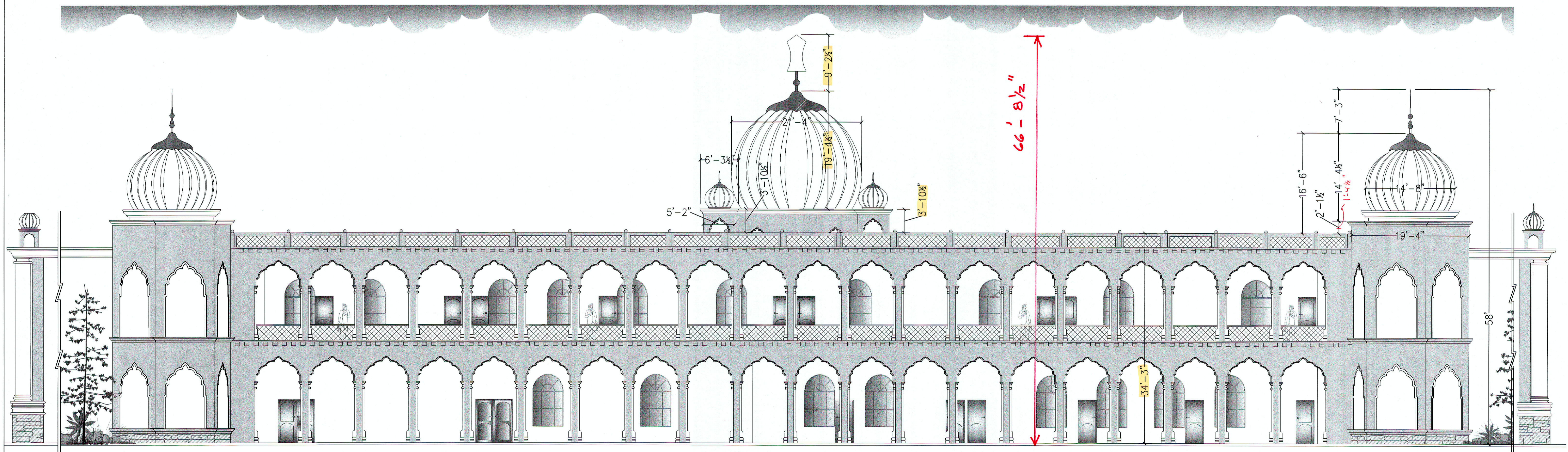

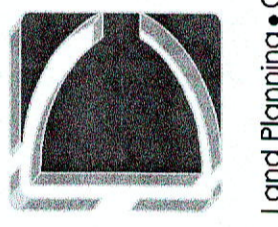
FRONT ELEVATION (SOUTH)

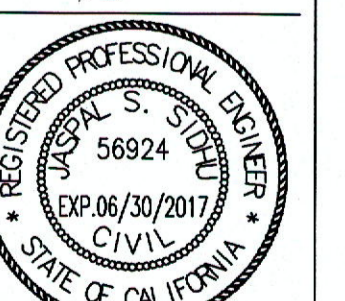
