SUMMARY PROJECT DESCRIPTION: The applicant requests approval of a Design Review Permit to develop a portion of the project site with a 5,200 square foot convenience store, a 1,458 square foot car wash building, a fuel canopy (with 6 pumps), and associated site improvements including parking, lighting, and landscaping. A Tentative Parcel Map is proposed to create a 2.1 acre parcel for the project and a second parcel for future development.

DETERMINATIONS FOR MITIGATED NEGATIVE DECLARATION
