- Only approved Non-Exclusive Franchise Haulers may be hired to collect and transport trash or mixed C & D material off of the job site.
- C & D may not be burned or dumped illegally.
- The Waste Generation and Disposal Report must be completed and submitted before your final inspection. (download or submit online)
