Program Qualifications

Have a City of Roseville Water Utility account

Replace a 1.6 gallons per flush (GPF) or higher toilet with a single flush 1.28 GPF or less or with a dual flush model with 1.28/.8 GPF or less

Replace a 1.28 GPF with a .8 GPF single flush model or dual flush model with 1.28/.8 GPF or less (Dual flush models with a 1.6 flush capacity do not qualify)

New toilets purchased must be WaterSense approved. Qualifying models can be found at www.epa.gov/watersense/products/toilets.html. Please note: EPA approved models must meet both requirements listed above to qualify

The entire toilet must be replaced (tank and bowl)

Provide a copy of the paid receipt(s). Receipt(s) must be dated within 60 days of purchase

Existing toilets: Submit two photos of each toilet being replaced. One photo of entire toilet prior to removal and one clear photo showing specifications (gallons per flush or date stamp or model)

New toilets: Submit two photos of each new toilet. One photo of entire toilet and one clear photo showing specifications.

Rebate expires 90 days from pre-inspection date.

The City of Roseville will not be held liable for any toilets replaced with non-qualifying models.

Residential Toilet Rebate Program Terms and Conditions

A. Toilet rebate program overview:

- The program will assist homeowners that are billed on a residential rate structure with costs related to replacement of their older, non-conserving toilets with newer, more efficient models.
- This program is available from July 1, 2026 through June 30, 2027, pending council approval. This program is subject to budget funding each fiscal year. Rebates are “first come, first served” and will continue until all toilet and urinal rebates have been awarded each fiscal year.
- The City of Roseville will rebate up to \$100.00 for qualifying models.
- Rebates may be considered income or a subsidy for tax purposes and may be taxable to the customer or the third party receiving the rebate check. Customers are urged to consult their own tax advisors concerning the potential taxability of these rebates. Rebate(s) greater than \$600 will be reported to the Internal Revenue Service on IRS form 1099, unless the customer is exempt. The City of Roseville shall not be responsible for any tax obligations that may be imposed on a customer as a result of the receipt of a Water Efficiency Rebate.
- Program qualifications outlined on page one of the application must be followed to qualify.
- Covered rebate expenses include the tank & bowl along with any accessories that come with it, i.e., supply line, wax ring, caulking, seat, bolts, bolt covers, in addition to tax. The maximum rebate will not exceed \$100.00 per qualifying model.
- Applicants must provide a copy of a paid receipt. The receipt must be dated within 60 days of purchase.
- Applicants must provide clear photos of both the existing and new toilets per guidelines outlined on page one of the application. Eligibility will be determined by a City of Roseville representative.
- Rebate expires 90 days from application date.

B. Who is eligible to participate in this program:

- Site address must receive City of Roseville water in order to qualify. Utility account must be in good standing to qualify.
- Applicant must meet all of the requirements listed on the Residential Toilet Rebate application. The City of Roseville is not responsible for equipment purchased or work performed in conjunction with this program.

C. How to participate:
