# Chief's message

On behalf of the Roseville Police Department, we proudly bring to you our summary for 2025. Our annual reviews provide a snapshot of the work being done by your Police Department every day to keep our community safe.

While this report is thorough, it really is just a peak into what our Officers and Professional Staff do every day in keeping with our Mission of providing outstanding service while working in partnership with our community to keep Roseville safe. Our role is to safeguard our community, protect life and property while reducing crime by enforcing the law impartially. These following pages will show you exactly how we do that every day.

Through the report, you'll see that crime has continued to decline in our city with reductions in nearly every crime category that we track. Those reductions are the result of the hard work of your Police Department and the efforts of you, our residents. Policing in our city is a partnership between your Police Department and you as our residents and businesses so when crime goes down, you've helped to make that happen. When you see a drop in burglaries, part of that is because you are doing your part to lock doors at home and with your cars, you're keeping an eye out for your neighbors, and you're not leaving high value items in your car for a thief to spot.

### Staffing and Recruiting

We have continued our strong effort at recruiting quality members of our Police Department team. We ended 2025 with all 159 of our officers positions filled, all of our Dispatcher positions filled, and just a few openings in our Professional Staff positions in Records and Property.

This year, we also added three new Police Officer positions. The first two officers began our buildout of a new Beat 8 as the west side of our city continues to grow. Over the coming two years, we will add six more officers to full staff the beat for Patrol. The third position added was a Detective position specializing in computer crimes. This added a second position to our Technology Crimes team to help with the increased workload in this specialized area.

### Thank You

As I write this opening to our report, I am just a few months from retiring after over thirty one years as a Police Officer. As a young police officer, Roseville was a great community to work in and a great Police Department to be part of. These last five years as your Chief of Police have been a great honor for me. I have had the opportunity to lead and work with the outstanding Police Officers and Professional Staff of our department. And I have been able to do that in a place where the community support of our Police Department by you our residents and businesses is exceptionally strong. 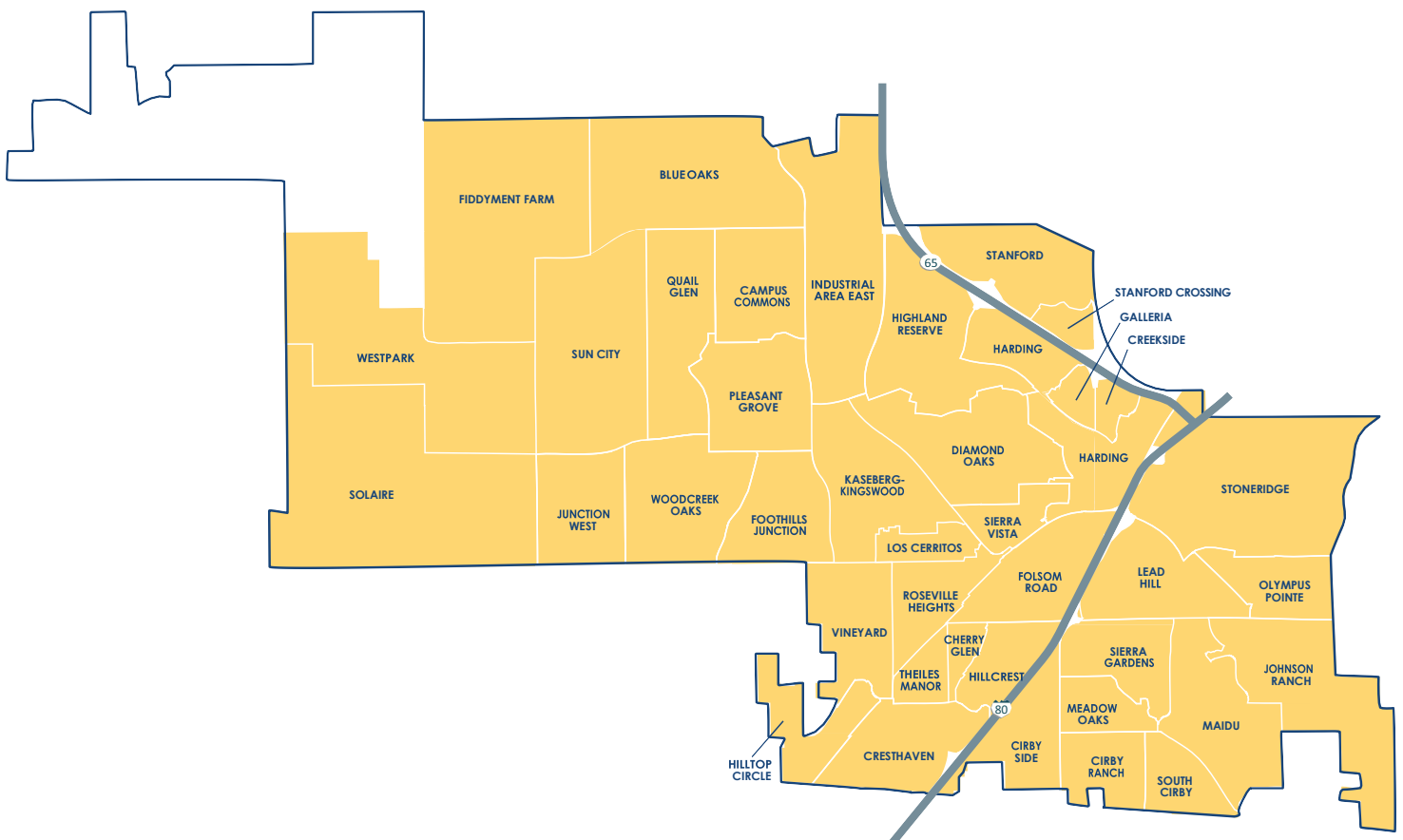

The City of Roseville is divided into 45 Neighborhood Associations that also act as police reporting districts.

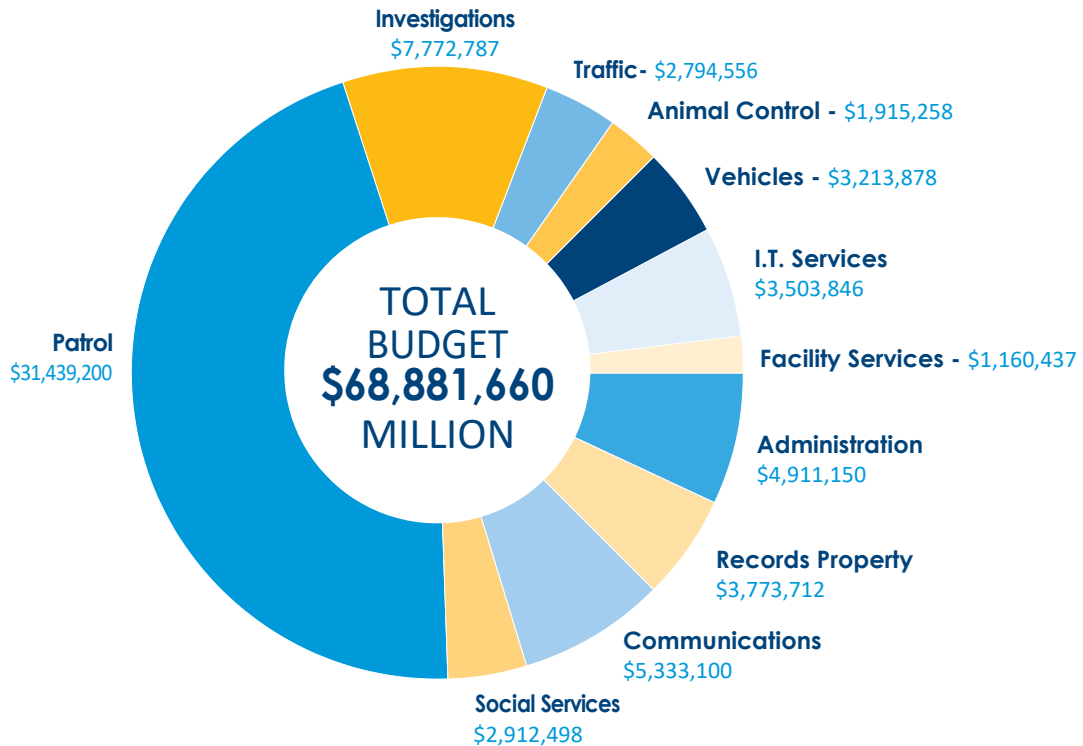

# Budget summary

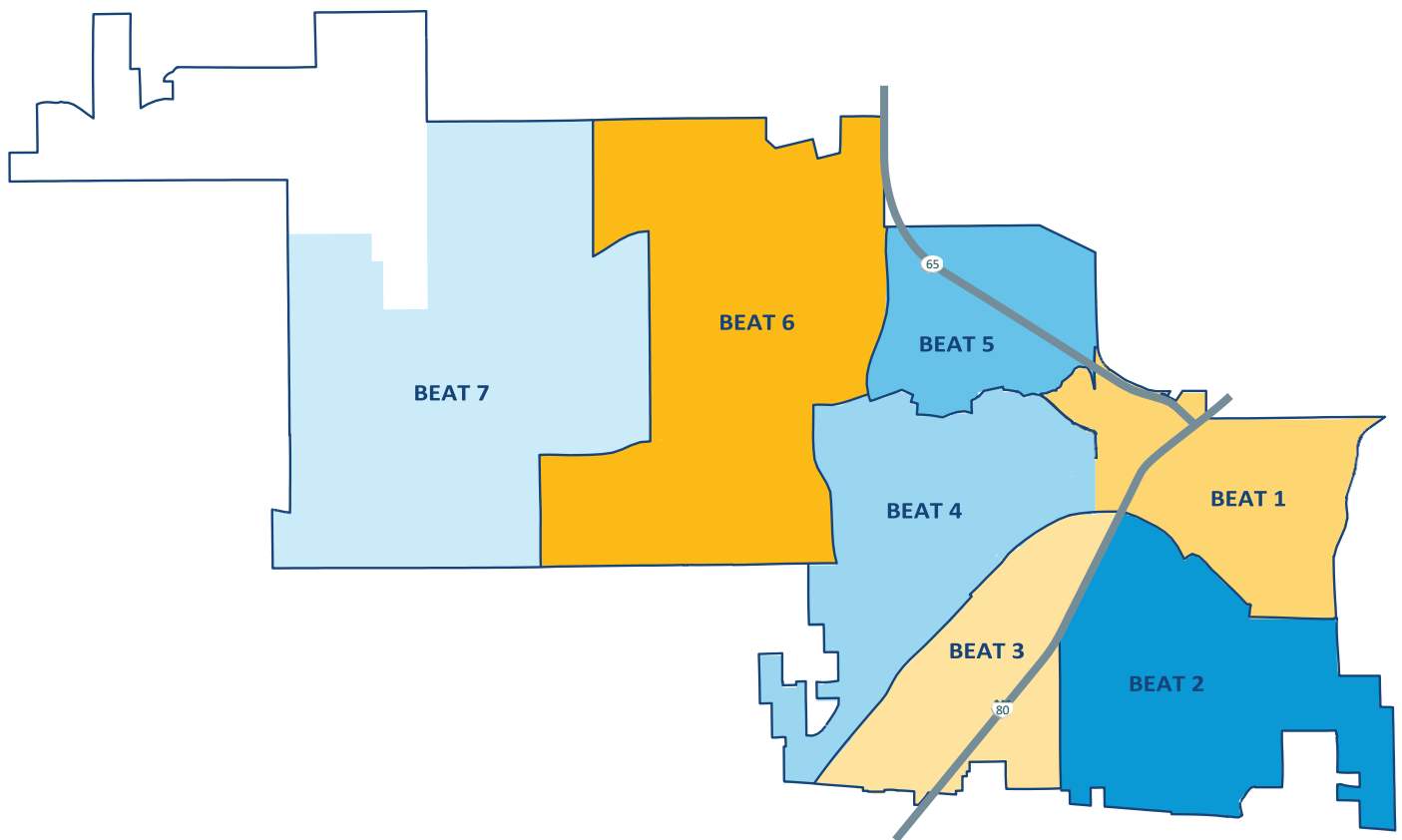

We do not have NIBRS statistics prior to 2023. It is not possible to compare NIBRS statistics to UCR summary reporting since they are completely different systems. UCR summary reporting was based on hierarchy of offenses, whereas NIBRS is a detailed system based on every offense within each incident. NIBRS should be considered a new baseline that will provide a more accurate depiction of crime.

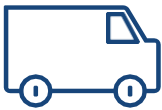

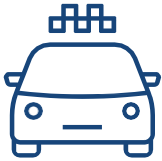

# Use of force

The Roseville Police Department tracks all instances when a peace officer employed by our Department uses force in the course of duty. In 2025 our officers proactively initiated contact or were dispatched to 75,178 incidents. Of those contacts 65, or .09% of all calls for service, resulted in an officer using force. Officers conducted 14,520 traffic stops with 7, or .05%, resulting in an officer using force.

**In accordance with state law, the Roseville Police Department must report to the California Department of Justice all use of force incidents resulting in serious injury or death. In 2025, the following information was reported to the California Department of Justice:**

- An incident that involves the shooting of a civilian by a peace officer: **0**
- An incident that involves the shooting of a peace officer by a civilian: **0**
- An incident in which the use of force by a peace officer against a civilian result in serious bodily injury or death: **2 (non-life-threatening injuries)**
- An incident in which use of force by a civilian against a peace officer results in serious bodily injury or death:

**In accordance with Department policy, we annually track and analyze all use of force incidents. The information from 2025 resulted in the following categories:**

- Total use of force incidents: **65**
- **65** incidents occurred while trying to arrest someone
- **29** of the **65** resulted in no injury or just a complaint of pain
- **34** of the **65** resulted in minor to moderate injury
- **2** of the **65** resulted in serious injury

# Citizen complaint reporting

**In accordance with state law, the Roseville Police Department must report to the California Department of Justice, all citizen complaints filed. In 2025, the following information was reported to the California Department of Justice:**

# 2025 Accomplishments

Policing through 2025 continued to provide opportunities and challenges. The Roseville Police Department was successful at executing several major initiatives. Here are three of the signature accomplishments that highlight our resolve and commitment to improving the quality of life in our community.

## Retail Theft Grant – Operation Grinch

During the month of December 2025, the Roseville Police Department led Operation Grinch to reduce property crime and organized retail theft during the holiday season. Over seven operational days, and in partnership with several law enforcement agencies, officers arrested 137 suspects and recovered more than \$23,000 in stolen property. Many of these arrests were charged as felonies under Penal Code 666.1, which applies to theft suspects with prior convictions. The Roseville Police Department thanks its Investigations Unit for coordinating this large-scale effort and the partner agencies whose collaboration made the operation successful.

## Drone First Responder Pilot Program Test

During 2025, the Roseville Police Department conducted a pilot program called Drone First Responder (DFR). The DFR Model involves stationing drones at strategic locations, having them networked to a workstation at the police department to be piloted remotely as opposed to driving to the location of the incident to then deploy the drone. This model of drone response was intended to reduce response times to certain calls, reduce the frequency of police being dispatched to calls where the drone could confirm no police response was needed, and increase our ability to gather critical information quickly to relay to our officers in real time before they arrive on scene. In those cases where a drone was deployed, 30% of those calls were able to be cleared without an officer and freed our patrol officers to respond to higher priority calls and engage in proactive enforcement throughout the city.

## Beat 8 Approval:

Beginning in February 2026, the Police Department will add an eighth patrol beat to better serve our growing community. Beat 8 was created in response to the city's continued westward expansion, which has brought increased residential and business development, as well as our growing population. Previously, this entire area was covered under Beat 7. By dividing that beat into two, we're able to provide more focused coverage and faster response times.

Staffing for Beat 8 will be implemented through a three-year build-out plan. While the beat will officially go live in February, additional officers will be added gradually, ultimately resulting in eight new positions (one per shift) once fully staffed. This expansion allows our department to respond more efficiently to calls for service and ensure we continue delivering the high level of public safety our residents and businesses expect.
